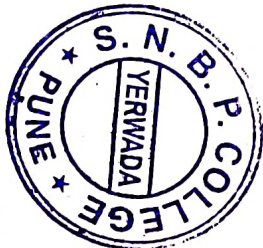

**Order**

As per Section 82 (4) of the Maharashtra University Act 1994, proposals for new (traditional / professional) colleges from the universities of the state have been received by the Government for approval. Proposals received from Universities as per the Government Decision No. vide NGC 2009/ (33/09)/ Mashi 3, dated 18 February 2009 the inspection has been carried out by the task force appointed. Taking into consideration the recommendations of the University and the Task Force, in accordance with the authority conferred under Section 82 (5) of the Maharashtra University Act, 1994, the following new professional colleges are being granted permission by the Government on a **permanently non-grant basis** from the academic year 2009-10 subject to the terms and conditions mentioned in paragraphs 2 and 3 :-

- (3). According to the criteria prescribed by the University and according to the educational qualification prescribed by the University Grants Commission, the colleges must appoint the teaching staff / staff and provide all other necessary infrastructure and ensure the same by the Departmental Joint Director till 30th August and only thereafter in the above condition no.2 The certificate should be given to the university.
- (4). New professional colleges shall not under any circumstances admit more than the sanctioned admission capacity.
- (5). The institutes to which the new professional college has been approved should obtain NAAC accreditation in the academic year 2009-10 and 2010-11 and if it

is not obtained within this period, the accreditation of the said college will automatically be cancelled.

- (6). This recognition shall be limited to the academic year 2009-10 only. If no new vocational college is started this year, this recognition will automatically stand cancelled.
3. The university should not start the process of granting affiliation without viewing the government approval order on the website of the government and obtaining the certificate of the departmental co-directors before taking the necessary further action regarding the affiliation of the university. Universities should send the completion report regarding affiliation to the Director, Higher Education, Maharashtra, Pune and the concerned Divisional Joint Director, Higher Education, Maharashtra State.
