### INTRODUCTION:

The Parliament enacted the Right to Information Act, 2005 (22 of 2005), which came into force on 15 June 2005. This Act provides citizens the right to information to secure access to information under public authorities' control to promote transparency and accountability in the working of every public administration.

All Universities and Colleges established by law made by Parliament or by State Legislature or by notification by the appropriate Government or owned, controlled, or substantially financed directly or indirectly by funds provided by the Government shall come within the meaning of a Public Authority under this Act.

Whereas some provisions of this Act have come into effect immediately on its enactment (on 15 June 2005), other conditions shall come into effect on 100/120 days of its implementation. Therefore, all universities and colleges are advised to carefully go through this Act and take necessary steps to implement various provisions, including proactive disclosure of certain kinds of information. Such information shall be made available to the public through the concerned university/college website.

The full text of the Act and frequently asked questions for implementation of the Act are available on the website www.righttoinformation.gov.in Objectives of the right to information Act: The primary object of the right to information act is to empower the citizens, promote transparency and accountability in the working of the Government, contain corruption, and make our democracy work for the people in an absolute sense. The Act is a big step toward informing the citizens about the Government's activities. An informed citizen is better equipped to keep necessary vigil on the governance instruments and make the Government more accountable to the governed. The college has up-loaded essential information on its website to benefit the aspirants, parents, stakeholders, and other citizens concerned about the college.

The following officers are appointed as Appellate Authority, RTI Officer, and Assistant RTI Officer in the college with immediate effect and until further orders. It is issued with the approval of the Competent Authority of the college.
